What's in it for me?

If you enjoy sports or socialising HFRSSA has lots to offer. From angling, football, cycling to sailing, dancing and theatre trips (to name but a few), the options are wide and varied. In sports all standards are catered for and encouraged, from the novice to the first class. The Association is affiliated to the Regional and National Fire Services Sports and Athletics Association enabling members to participate at all levels. Over the years Hampshire boasts many individual and team achievements at these levels. In addition all members benefit from insurance cover whilst engaged on approved activities and receive a HFRSSA diary.

How is it managed?

The Chief Officer is the President of the Association. For administration purposes at Service level there is an Executive Committee (elected at the Annual General Meeting) who carry out the duties as laid down in the Association's constitution. HFRSSA operates on three geographic areas i.e. East, West and North Hampshire. Each has its own sports and social committee who meet quarterly to encourage and support approved activity in their area and provide updates to keep local members informed. Each station has a representative who attends the meetings and are able to request grant support for approved sports and social activity.



How much does it cost and how do I pay?

The subscription, presently £19.20 per year for each associate member, is payable by standing order on 1st April. The subscriptions are used solely to further the aims of the Association.

How do I join?
