Freedom of Information Act 2000

Dear 

We are writing in respect of your application for the release of information held by the Service, which we received on 28 April 2023. We can confirm that we have now completed our search for the information requested.

You asked:

As per my records, YBC cleaning contract has expired. I would like to know whether this contract is still valid or replaced by any other supplier.

If all the information besides the contract dates are the same, I am happy to just receive an update on the contract dates

Below highlighted original FOI request for your reference only.

I would like the organisation to review my freedom of information request below, that's focused around contract data for services around facilities management.

1. Office and building cleaning – Service contract that is focused around office, commercial and building cleaning services.

Contract profile questionnaire for each type of contract:

- 1. Supplier/Provider of the services*
- 2. Total Annual Spend – The spend should only relate to the service contract listed above.*

3. *A description of the services provided under this contract please includes information if other services are included under the same contract.*
4. *The number of sites the contract covers*
5. *The start date of the contract*
6. *The end date of the contract*
7. *The duration of the contract, please include information on any extensions period.*
8. *Who within the organisation is responsible for each of these contracts? name, Job Title, contact number and email address.*

Our answer:

We can confirm we hold the information requested. The contract has been awarded to N-Viro for the cleaning (office, commercial and building cleaning) of our sixty-two sites. The contract started on 1 December 2022 and is set to end on 30 November 2024. As the contract only commenced in December we do not hold (as per Section 1 of the Freedom of Information Act 2000) a total annual spend, but we can confirm that the spend between December 2022 and March 2023 was £140,000.

We are refusing to provide the information for question 8 as it would be unfair, within the meaning of the UK GDPR, for us to identify an individual to the world at large in response to a Freedom of information request. As such we are refusing to provide this information as per Section 40 of the Freedom of Information Act 2000.
